

District School Improvement and Accountability Council Minutes from November 18, 2014

Welcome, Introductions, and Approval of the October Minutes: Kristen Tourangeau called the meeting to order at 6:45 p.m. The minutes from October 28, 2014, were reviewed. Jesse Sutherland moved for approval and Ed Shackelford seconded the motion. The minutes were approved.

Board of Education Update: Kristen Tourangeau invited Arturo Jimenez to attend the meeting. He responded that if possible he would attend but he would probably be late. She said that she will invite Happy Haynes to the District SIAC January 6 meeting.

Committee Reports:

- Budget and Finance - - Lynn Otto reported that the November 12 meeting was cancelled. She will send information by email regarding a December meeting.
- UIP (Unified Improvement Plan)/Denver Plan - - Kristen Tourangeau reminded the Council that Colorado school districts should have received their ratings from the Colorado Department of Education by August 15. She will find out the DPS rating and report back to the Council. Members of the UIP Committee are Sherry Eastlund, Dorolyn Griebenaw, Roger Kilgore, Jesse Southerland, and Kristen Tourangeau.
- Charter Schools - - Kristen Tourangeau shared that there were two alternative schools that did not meet the conditions of their contracts and the Charter School Committee made the decision to not review those schools. The schools reviewed are listed below:

- Segregation in the District - - It was brought to the Council's attention that last week the Board of Education discussed segregation in the District. Factors that might play into segregation were discussed and included the choice process, magnets, and charters.
